
Poverty: Delaware ranks **21st** in childhood poverty at **22.4** percent.

I	Average Freshman Graduation Rate (AFGR): Increased from 69.5 to 75.5 percent from 2002 to 2010 Average of 0.8 points per year	Needs to increase 1.5 points per year starting in 2010 to reach 90 percent by 2020
II	Class of 2010 had 646 more graduates than Class of 2002	Class of 2020 needs 1,561 more graduates than Class of 2010 to reach 90 percent
III	1 fewer dropout factory in 2011 than 2002	In 2011, there were 7 dropout factories. To reach 0 by 2016, 2 schools need to improve per year.
IV	3,159 fewer students attended dropout factories in 2011 than 2002	7,719 students still attend dropout factories in 2011

All but 3 states report the new rate. Idaho and Kentucky were issued waivers from the USDOE allowing them until 2013/2014 to report the new rate. Oklahoma has applied for a waiver and is awaiting approval.

ECONOMIC BENEFITS

With a 90 percent graduation rate, the additional graduates could deliver an estimated \$15 million in increased annual earnings, \$2.3 million in increased annual state and local tax revenues, and an increase in the Gross State Product of \$19 million.
